Historic Resources Survey Completed by County Historic Landmarks Commission By John Allen, President, JCHLC

Jefferson County Historic Landmarks The Commission has recently completed a survey of historic resources in the county. Consultant David Taylor, of Taylor & Taylor Associates, worked with the landmarks commission to compile data on more than 2000 historic sites and structures. The survey used the Department of Interior standards for recording all buildings and sites over 50 years old, including houses, barns, schools, churches, mills, kilns, quarries and battlefields. Historic resources were located, evaluated, and photographed in accordance with the requirements of the State Historic Preservation Office. Details of each resource were recorded on West Virginia state survey forms, which include date of construction and/or significance, material, style, and address.

The new map and database of historic sites and structures can be accessed online at the Landmarks Commission web site:

http://jeffersoncountyhlc.org. Once there, click the "Map/Database" link in the "NAVIGATE" section. A map will pop up to show the locations of those historic resources in Jefferson County outside incorporated towns' limits. The corresponding database contains information on each of the historic sites and structures and is also available on the web site. Funding for the survey was provided by the West Virginia State Historic Preservation Office, the Jefferson County Commission, and the Jefferson County Historical Society. This comprehensive survey and its corresponding database should be of use to historians for years to

come. The Jefferson County Commission and planning office have also been given access to this valuable information, where it can be employed to protect historic resources. The Jefferson County Historic Landmarks Commission would like to thank the Jefferson County Historical Society for its generous support during this important project.

County Landmarks Commission Establishes New Web Site

A new web site developed for the Jefferson County Historic Landmarks Commission is now online at http://jeffersoncountyhlc.org/. The site contains listings of all the Jefferson County Landmark properties as well as those listed in the National Register of Historic Places. It also describes the ongoing projects of the Commission, including the Peter Burr House and the Alms house, and provides a calendar of events related to local history.

The Museum Corner by Jim Glymph Civil War Identification Badge



In the early part of the American Civil War, soldiers on both sides, before going into combat, pinned a piece of paper with their name other and pertinent information on their uniform. This was done because there were no issue

identification tags. Entrepreneurs in the North recognized this need for a more substantial form of identification and began selling metal tags to the soldiers. Southern soldiers did not have this resource; therefore, a Confederate tag is very rare. The Jefferson County Museum has recently acquired a Union tag. It doubles as an identification tag and a Corps badge. It is silver and is in the shape of a shield with the cannon and anchor emblem of the Union Ninth Corps engraved in the center. It belonged to Private Oliver P. Townsend, Company B, Massachusetts Infantry Regiment and is so engraved. Townsend was wounded at Antietam on September 17, 1862. Records show that his regiment was in Jefferson county on several occasions. He survived the war and died in Newburyport, Massachusetts April 1, 1909. The pin is broken on the back. Due to this fault, it could have been lost or discarded. It belonged to a Jefferson county family (not related to Townsend) but nothing is known of its history. Shepherdstown Battlefield Preservation Legislation Introduced

Senator Robert C. Byrd introduced legislation asking for authorization for a National Park Service "Special Resources Study" to document the site of the 1862 Battle of Shepherdstown. This is the first of several steps that are necessary

for the Shepherdstown site to be included within the boundaries of an existing National Civil War Park.


